DECLARATION AND DETERMINATION Probable Cause for Warrantless Arrest

On 01/04/21, at 1232 hours, LPD Officers were dispatched to [withheld address] in Livermore for a suspicious circumstance. CHP Dispatch had received a 9-1-1 call, which they transferred to the Fire Department, which was ultimately transferred to LPD. The caller identified himself as Timothy Young. Timothy stated he had been raped and that his Dad was dead in the house. Timothy stated he had been stabbed and could see his own intestines. At 1243 hours, Timothy exited the front door of the residence and was escorted to medical personnel for emergency medical treatment. Timothy was transported to Eden Hospital.

LPD Officers located a deceased adult male inside the residence lying in a pool of partially dried blood. The deceased victim was later identified as Timothy's father. DECENDANT's body was cold to the touch and had rigor mortis.

I spoke to Timothy's mother who stated the following:

Timothy was diagnosed with Schizophrenia and refused to take his medication. Timothy had hallucinations and delusional thoughts that she was not his mother and that she had an affair with his former landlord.

On 01/02/21, Timothy's mother woke up in the morning to Timothy wailing and crying. Later in the day, Timothy wrapped his arm around his mom's neck from behind and squeezed until the DECENDANT told him to stop. Timothy also attempted to strangle the DECENDANT and was yelling "Let my Mom go!" Timothy was going in and out of his bedroom and at one point grabbed a kitchen knife and held it in the air. Timothy walked up to his mother and punched her twice in the chest, causing visible injury. Timothy's mother was afraid for her safety so she left to stay at a friend's house for a few days.

On 01/03/21, the DECENDANT and Timothy brought her dinner. At 2345 hours, the DECENDANT called Timothy's mother and explained that Timothy was hearing voices in his head and that the voices were telling him to kill the DECENDANT. The DECENDANT stated he would stay in his bedroom and lock the door.

In the morning of 01/04/21, Timothy's mother tried to call DECENDANT, but he was not answering. Timothy's brother called Timothy at 1220 hours asking for DECENDANT. Timothy stated that DECENDANT wasn't home (6 minutes later Timothy called 9-1-1 and stated DECENDANT was dead inside the house).

There were no signs of forced entry into the residence, although the back-sliding glass door was unlocked. There were not shoe prints inside or outside of the sliding glass door and the curtains remained closed. Neighbors noted hearing multiple loud banging noises on 01/04/21, between the hours of 0100 and 0300.

All of Timothy's stab wounds were to the front of his body. Of note, Timothy had a deep laceration to the palm of his right hand (dominant hand) and a deep laceration to the inside of his left wrist. A doctor treating Timothy stated that his stab wounds and injuries could have been self-inflicted based upon their locations and depth.

Timothy was placed under arrest for 187(a) PC-Murder.

On 01/08/21, Timothy was transported from Eden Hospital to LPD for interviewing. I read Timothy his Miranda Rights and he stated "yes" he understood each of his rights and wished to speak to me.

In summary, Timothy stated that he was not Schizophrenic. Timothy stated that he went to bed on 01/03/21 at approximately 2100 hours in his own bed. Timothy awoke to himself kneeling in his father's bedroom. Timothy stated he was being "orally raped" by his former landlord and his brother. Timothy did not see the attackers, but he heard and recognized their voices. Timothy heard his Dad screaming and then "blacked out".

Timothy woke up lying in a pool of blood next to the DECEDNANT. Timothy stated he was screaming in pain and "blacked out" again. Timothy then woke up when it was light outside because he heard his cell phone ring. Timothy stated that his brother had called him to ask if the DECENDANT was dead. Timothy then realized he was severely injured and called 9-1-1.

Timothy was transported and booked at Santa Rita Jail on 01/08/21.
